ORDER

CM APPL. 64232/2025

1. The present application has been filed on behalf of respondent no.1, i.e., Roller Skating Federation of India ("RSFI") through its General Secretary, Dr. Bhagirath Kumar, seeking directions to the President of RSFI to hand over records to the General Secretary.
2. Learned Senior Counsel appearing for respondent no.1 submits that respondent Federation, i.e., RSFI, has duly elected the General Secretary,



who is the applicant before this Court. However, he has been obstructed and divested of his statutory functions by the President of RSFI, in complete contravention of the RSFI Constitution.

3. Learned Senior Counsel appearing for respondent no.1 submits that Dr. Bhagirath Kumar was elected as General Secretary of RSFI on 24th May, 2025 and Mr. Tulsi Ram Agarwal was re-elected as President.

4. It is submitted that under Rules 13(b)-(d) and (m) of the RSFI Constitution, the General Secretary is the sole statutory custodian of all records, properties, correspondence, minutes and accounts of RSFI, with a constitutional obligation to supervise, direct and control all its affairs.

5. However, it is submitted that from the very day of his elections, the applicant has been stonewalled from discharging his functions and the same is evidenced by the detailed and consistent body of correspondence exchanged over several months between the respondent no.1-Dr. Bhagirath Kumar, Secretary of the RSFI and Mr. Tulsi Ram Agarwal, President of RSFI.

6. Thus, the present application has been filed for directions to the President of RSFI, Mr. Tulsi Ram Agarwal, to forthwith and unconditionally handover the entire records, registers, minutes, accounts, bank access, passwords, correspondence, files, physical properties, E-mail and domain credentials and all other properties of RSFI to the elected General Secretary, Dr. Bhagirath Kumar.

7. Issue notice. Notice is accepted by learned counsels appearing for the petitioner and respondent nos. 2 and 3.

8. Notice is also accepted by learned counsel appearing for the President of RSFI, Mr. Tulsi Ram Agarwal.



9. Learned counsel appearing for Mr. Tulsi Ram Agarwal submits that Mr. Tulsi Ram Agarwal is not a party before this Court.
10. At this stage, learned counsel appearing for the petitioner submits that there are in-house disputes in the respondent no.1-Federation, on account of which, the young players are suffering.
11. Considering the submissions made before this Court, with the consent of the parties, Mr. Tulsi Ram Agarwal, President of RSFI, is impleaded as respondent no.4 in the present writ petition.
12. Let amended Memo of Parties be filed by learned counsel appearing for the petitioner, within a period of one week.
13. Copy of the present writ petition, along with all the requisite annexures, applications and other pleadings, be provided to learned counsel appearing for the newly impleaded respondent no. 4.
14. Let reply to the present application, as well as to the writ petition, be filed by the newly impleaded respondent no. 4, before the next date of hearing.
15. This Court notes that other respondents have also not filed their replies to the main writ petition itself.
16. Accordingly, let reply be filed by the other respondents, as well as the petitioner, to the present application, i.e., *CM APPL. 64232/2025*. Further, the respondent nos. 1 to 3 shall file reply to the present writ petition also.
17. Let the needful be done, before the next date of hearing.
18. Re-notify on the date already fixed, i.e., 07th November, 2025.
