### **Subject: Clarification regarding the conduct of the 63rd National Roller Skating Championship and completion of State Championships, selections, and submission of entries**

**It has come to the notice of the Federation that certain disgraced individuals — Ex-Secretary Mr. Naresh Sharma and President Mr. Tulsi Ram Agarwal — against whom formal enquiries are in progress on serious charges of misappropriation of funds, corruption, forgery, fraudulently obtaining international merit certificates, misadministration, and authoritarian functioning, are spreading misinformation regarding the conduct of the 63rd National Roller Skating Championship.**

The Roller Skating Federation of India hereby categorically clarifies that the 63rd National Roller Skating Championship will be held at **Visakhapatnam, Andhra Pradesh, from 5th to 15th December 2025**, in strict compliance with the orders of the Hon'ble High Court. There is no change whatsoever in venue, schedule, or timing. Any claim suggesting otherwise is false, misleading, and unauthorised.

The Championship is being organised solely under the authority of the **Roller Skating Federation of India (RSFI)** — the only recognised national governing body for roller sports in India, recognised by the Ministry of Youth Affairs & Sports, Government of India, and affiliated to World Skate and World Skate Asia.

It is deeply regrettable that **Mr. Naresh Sharma** and **Mr. Tulsi Ram Agarwal** are issuing unauthorised communications to State Associations and individuals. These discredited persons have no authority whatsoever to issue directions or interfere in Federation matters.

**By bypassing the affiliated State Associations and infringing upon their legitimate authority, they have grossly violated the Federation's constitutional structure and governance norms.** For the first time in RSFI history, they have resorted to sending unauthorised messages and emails to skaters, parents, coaches, and even international contacts, causing confusion, disruption, and disrepute to the sport.

**All affiliated associations and stakeholders are strongly advised not to act upon, circulate, or rely on any communication emanating from these disgraced individuals, who are facing grave allegations of fraud, forgery, and misadministration.**

It is further evident that they are deliberately attempting to implicate members of the Executive Committee in their alleged acts of corruption, to divert attention from their own misconduct. **The Federation will initiate appropriate legal and disciplinary proceedings to safeguard the integrity of RSFI and protect the interests of its affiliated units.**

**All affiliated State Associations and Units are hereby directed to:**

1. Complete their respective State Championships and selection trials immediately to ensure the timely finalization of eligible athletes for the Nationals.
2. Submit both hard copies and soft copies of the approved entries, along with all supporting documents, to the following:

**The Roller Skating Federation of India seeks the cooperation of all affiliated associations to ensure the timely completion of State Championships and selections, and the successful, dignified, and orderly conduct of the 63rd National Roller Skating Championship.** All members are urged to discourage and report any misinformation or unauthorised activity that may harm the interests of skaters or the reputation of the sport.
